## MEMORANDUM OF AGREEMENT

# FACULTY OF PHARMACY UNIVERSITAS PANCASILA AND FACULTY OF PHARMACY PRINCE OF SONGKLA UNIVERSITY

Faculty of Pharmaceutical Sciences, Prince of Songkla University and Faculty of Pharmacy, Universitas Pancasila conclude this official agreement with the objective of promoting cooperation in the fields of academic research and education between the two universities under an equally beneficial principle.

### Article I

Faculty of Pharmaceutical Sciences, Prince of Songkla University and Faculty of Pharmacy, Universitas Pancasila agree to promote the following activities of mutual interest:

- 1) Students mobility
- 2) Staff visits/short attachment
- 3) Teaching exchange
- 4) Undergraduate research placement
- 5) Research collaboration
- 6) Conference collaboration
- 7) Reviewer for journal

### Article II

For implementing he agreement, financial and other arrangements shall be negotiated and determined separately for each case.

### Article III

Results and publications gained from the research collaboration are managed as follows:

- All materials and information that arise from the activities of the Article I shall be freely available for research and educational purposes to both of the two faculties.
- 2) Any commercial exploitation of the materials, information and intellectual property that arise from the activities of Article I shall be jointly made by both of the two faculties and be the subject of separate agreements. Of any research materials are also managed based on each regulation and being the subject of separate documents.
- Publications within the framework of the activities under this Agreement shall be jointly made by both faculties.
- 4) All materials and information that arise from the activities of Article I shall be limited to peaceful purpose and shall not be utilized for peace-threatening activities.

### Article IV

The agreement takes effect from the date of signing for five years and continues its effect for the period unless either university states otherwise. Each faculty may terminate the Agreement at any time by notifying the termination by written notice at least six months in advance of the termination.

### Article V

Any modification to the Agreement shall be conducted based on the mutual consent of both faculties.

# Article VI

The agreement shall be written in English and take effect when signed by the representatives of each university (faculty). Each university (faculty) retains one set of copies.
